Provisional Citizenship Registration Certificate

Let it be known by this declaration here forth, that on Thursday, June 30, 2016, the

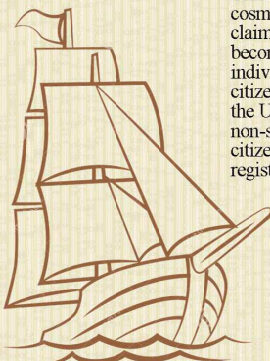

is hereby adopted and henceforth registered in voluntary presentation to the Global International Board of Commissioners based on the verification of birth, life, legal existence, civilization, freewill, good standing and the showing of proof that they were born of this earth with a unalienable divine individual right to exist, live in peace, pursue human rights, and flourish on the planet as a free, good, conscientious, equitable and natural sovereign being during a lifetime.

The individual superscribed herein has been qualified and assigned the permanent registry number **N° 0000027** having been officially recognized as an eligible self-declared non-political independent registrant with a genuine lifetime personal interest in the common good, world society, peace, civil order, social justice, equality, the global ecosystem and universal human rights notwithstanding their native state or nation of natal birth. Andreas Klammm shall be henceforth known by our commission through the integrity demonstrated in this action to be recognized as an honorable, socially responsible, ecologically sustainable, equitable, and fully entitled universal world citizen among peers, Communitas Gaea and all of the world's understanding peoples.

The registrant, certified herein has exercised the benefit of their cognitive liberty to affirm a lifetime of self-determination to pursue all their individual natural rights, legal universal human rights and exercise civil liberty to freely associate with others internationally all around the world under accepted and well-known international laws that prevent discrimination, promote global ethics, exemplify individual social responsibility, and foster human liberty in person, virtually using computers, in member countries and in our mutual friendship, legal ownerships, and commercial relationships through being part of the formation of a global member held society of friends that is a non-state, non-governmental cooperative international offshore foundation and federated decentralized sovereign state civil development society.

This certificate authorizes the registrant to gain unlimited confidential access to international cosmopolitanism information, education, accreditation, and certification programs to apply and claim lifetime citizenship privileges. The holder of veritas aequitas may exercise the right to become employed as a permanent legal owner of a single equal cooperative share of interest as an individual participating stakeholder in our pilot model for a (non-state, non-governmental) global citizenship with the Global International Sustainable Development Goals Action Campaigns under the United Nations. Registrant herein further bears a lifetime right to enter into a permanent legal non-state relationship under the protection of private international law governing our global citizenship to obtain laissez-faire laissez-passer in confidence as a natural person with our other registered persons as fellow global citizens, henceforth.

Our project will lead to special accommodations, treaties and visas for travel as well as global human assistance and service network of friends who are fellow global citizens (responsible activists) and ambassadors. We have a 15 year window to prove the viability of our program and operate on a test (trial) basis.

This first edition certificate was done with digital paper and a ship to symbolize our charter, independence and legal state as if we were all on board a single ship. Future members will receive certificates that use a standard background and an image other than a ship.
